## About Humanity in Action

**H**umanity in Action is an international educational organization that educates, connects and inspires a global network of students, young professionals and established leaders committed to promoting human rights, diversity and active citizenship—in their own communities and around the world.

Humanity in Action's annual Fellowship programs bring together university students and young professionals from Europe and the United States to discuss, learn and research the pressing human rights and diversity issues confronting our societies. In 2010 and 2011, Humanity in Action Fellows met with leading experts and activists to study historical and contemporary challenges to diversity and pluralism in Denmark, France, Germany, Poland and the Netherlands. Fellows also wrote articles, formulate policy proposals and develop educational tools to share what they learn in their programs. Humanity in Action supports all Fellows financially for the duration of their

programs, which allows for the merit-based selection of diverse applicants.

Humanity in Action also provides its Senior Fellows (the alumni of its programs) with a range of educational and professional development opportunities, including international seminars and study trips, lecture and discussion series, and fellowship positions at the European Parliament, the U.S. Congress and other civic and political institutions. Nearly six in ten Senior Fellows have received a professional opportunity through Humanity in Action. These opportunities create links between generations of civic, national and global leaders.

Humanity in Action's network of students and young professionals is a unique and valuable resource for policy-makers, diplomats, educators, business leaders and civic-minded individuals and organizations. By 2015, Humanity in Action will connect over 3,000 professionals—including 1,400 Fellowship alumni in their 20s and 30s—working in all

sectors on a range of critical issues in countries around the world. The extensive Humanity in Action network contributes in innovative ways to the global advancement of human rights and democratic freedoms. Three quarters of Senior Fellows now work in a field related to human rights and social justice.

Humanity in Action is a non-profit, non-partisan organization with governing and advisory Boards in Bosnia and Herzegovina, Denmark, France, Germany, the Netherlands, Poland and the United States. Humanity in Action's international headquarters is in New York City.

Major supporters have included the Ford Foundation, the Mellon Foundation, Richard and Rhoda Goldman Fund, the Foundation "Remembrance, Responsibility and Future" (EVZ), the Dutch Ministry for Health, Welfare and Sport (VWS) and the U.S. Department of State. Over 14 years, Humanity in action has raised more than \$16 million for its work.

## Letter from the Chairman of the Board

During the past two decades, democracies have blossomed throughout Europe, Latin America, Asia and parts of Africa. Now forces of liberation have been unleashed in North Africa and the greater Middle East. It remains unclear whether those forces will yield democratic societies as they did elsewhere or if radical Islamic regimes will step into the breach. The process has been violent and the result may well be a mix of the two. In some cases, civil conflict threatens to become regional conflict.

The Great Recession has complicated this picture, particularly in Europe. The future of the European Union and its social values are at stake as financiers struggle with sovereign debt and stability of the Euro. Economic tensions exacerbate relations between indigenous populations and immigrants. The fundamental relationship between majority governments and their ethnic and religious minorities is up for review. Nationalist parties have done relatively well at the polls in many countries. Tragic acts of domestic terrorism perpetrated by lone actors have cost innocent lives in the name of protecting cultural values.

In the United States, the two principal

political parties have been unable to compromise and pursue needed economic and social reforms. In Latin America, several nations have returned to extreme forms of socialism cloaked in nationalism. In Asia, human rights progress in Myanmar is celebrated but Chinese human rights, currency and maritime practices have their neighbors seeking support from the United States. In Russia, hopes for true democracy have waned with the dominance of Vladimir Putin. In Africa, many authoritarian regimes in places like Zimbabwe resist the transition to democracy.

So democracy around the world is at an inflection point. Tremendous progress has been made but severe challenges are on the rise. The challenges are global in scope and generational in duration.

As this generation and the next design approaches to these complex challenges to democratic values, sound leadership with inclusive values will be critical. That leadership is forged in education. This is where Humanity in Action comes in. Humanity in action continues to promote diversity, pluralism, and fundamental rights, and to educate the next

generation of leaders about the value of these ideals.

Through its programs and impressive network of international activists, experts, professionals and mentors, Humanity in Action educates and equips young leaders for the challenges ahead. Despite difficult economic times, the organization has expanded its reach through new initiatives: Humanity in Action Bosnia and Herzegovina was legally incorporated; Turkish students will participate in the 2012 Humanity in Action Fellowships; Humanity in Action Denmark led a study trip to the Middle East; Humanity in Action published its first book and produced its first film; and, of course, its Senior Fellows continue to magnify and multiply its efforts globally.

As Humanity in Action’s mission becomes more urgent with each passing year, we are profoundly appreciative of those who share our goals: guest speakers, Board members, advisors, contributors and friends. Your engagement makes possible our efforts in these unpredictable, challenging times.

## Letter from the Founder and Executive Director

In many respects, 2010 and 2011 were remarkable years for Humanity in Action. They were a period of accomplishments—major initiatives that came to fruition after many years of planning and much work. These breakthroughs were also achieved while Humanity in Action continued its outstanding Fellowship programs in Denmark, France, Germany, Poland and The Netherlands, as well as professional fellowships in Brussels, San Francisco, Vienna and Washington, DC.

In 2010, the annual Fellowship programs culminated in the inaugural Humanity in Action International Conference in Amsterdam. The conference was a marathon of talks, workshops, sites visits and non-stop conversations for all members of our network, including Fellows, Senior Fellows, donors, Board members and friends. It was a chance to share experiences, knowledge, energy and innovative ideas. Building upon this success, we organized the second International Conference in partnership with the Bertelsmann Foundation at its stunning building on Unter den Linden in Berlin in 2011. Humanity in Action is grateful, as always, to the Dutch government, particularly the Ministry for Health, Welfare and Sport

(VWS), for providing the major grants for these conferences.

During the 2011 International Conference, Humanity in Action took the opportunity to launch its first publication and film: *Reflections on the Holocaust* and “Just People.” This emotionally and visually stunning book is a compilation of essays by our Fellows and speakers. The film “Just People” is the work of the outstanding Dutch filmmaker Annegriet Wiestma. It is a gripping examination of the actions and values—histories, behaviors and attitudes—that are the foundation of Humanity in Action’s work. We look forward to the wide distribution of both the book and film.

Humanity in Action also fully entered the digital age! An outstanding new website came online in June 2011 with social media tools that are already helping our Senior Fellows connect and collaborate. We caught up with the latest communication technologies with a website that is immensely handsome and usable.

Finally, it is important to note that each of our national offices met the challenge of raising sufficient funds for its operations. What a challenge it has been in this period of economic retrenchment and uncertainty. And

Humanity in Action remains ever dedicated to the challenge of enhancing diversity and pluralism in the countries in which we have programs and, through our growing network, on a global scale. We select outstanding Fellows, support the impressive careers of our Senior Fellows and address immensely difficult moral, historical, social and cultural issues. We encourage responsibility and action. In all of these pursuits we are deeply grateful to those who take on the challenges with us.

## Humanity in Action Fellowship Programs: 2010 and 2011

Intensive and demanding, the Humanity in Action Fellowship is Humanity in Action's flagship educational program. Every summer, the Fellowship brings together an international group of university students and recent graduates to explore contemporary issues affecting minority groups in the context of national histories of discrimination and resistance. The goal is to educate and inspire the next generation of leaders to be active defenders of diversity and democratic values in our societies.

In the summers of 2010 and 2011, Humanity in Action organized five-week programs in Denmark, France, Germany, The Netherlands and Poland. Each program was highly interdisciplinary and focused on drawing lessons from history to understand the social and political roots of discrimination as well as different strategies for remedying injustice. The curricula featured lectures and discussions with

renowned academics, journalists, politicians and activists, as well as site visits to government agencies, non-profit organizations, museums and memorials. At the end of each program, Fellows produced original work ranging from research papers to interactive teaching tools that can be used in high school and university classrooms.

Each Humanity in Action Fellowship program brings together students representing an array of nationalities, perspectives, academic interests and personal and professional experience with human rights and diversity issues. This ensures that everyone is challenged by new ideas and insights. Both in 2010 and in 2011, annual participants included over 100 Fellows from the five countries in which Humanity in Action ran programs as well as Bosnia and Herzegovina, Sweden, Ukraine and the United States. Humanity in Action funds the vast bulk of all Fellows'

expenses so that it may continue to provide opportunities to the most qualified applicants.

Participation in the programs is not an end in and of itself; Humanity in Action's broader goal is to instill in its Fellows a lifelong responsibility to protect minorities and promote human rights in their own communities and around the world. Thus, Humanity in Action Fellows develop Action Projects in the year following their program. These projects are hands-on initiatives that offer Humanity in Action Fellows the opportunity to apply an idea, experience or example of social innovation that inspired them during their five-week program. Some of the excellent projects from the last two years are featured [opposite]. Fellows are subsequently invited to take advantage of lifelong opportunities to learn, collaborate and take action through the global community of Humanity in Action Senior Fellows.

## Humanity in Action International Conferences

In 2010, Humanity in Action inaugurated an ambitious new program of annual international conferences in order to serve its growing network of Senior Fellows and friends. Humanity in Action has always intended for its Fellowships to be just the starting point for lifelong opportunities to learn, collaborate and take action through the Humanity in Action network. With this in mind, the international conferences are designed to introduce each year's new Fellows to the network and provide a forum for Senior Fellows and friends to reconnect, share ideas and be re-inspired.

The international conferences, timed each year to coincide with the completion of the summer Fellowships in Europe, bring together Humanity in Action Fellows, Senior Fellows, Board members, supporters, friends and partner organizations. The program includes interdisciplinary lectures, skills-building workshops, discussion groups and presentations of grassroots projects that demonstrate how the Humanity in Action community is resisting intolerance and injustice. A wide range of human rights issues are explored from transatlantic perspectives, reflecting the diversity of interests, experience and backgrounds within the network.

The first Humanity in Action International Conference was held in Amsterdam in 2010 and the second in Berlin in cooperation with the Bertelsmann Foundation in 2011. The conferences have received generous support from the Dutch Ministry of Health, Welfare and Sport (VWS), the Foundation "Remembrance, Responsibility and Future" (Stiftung "Erinnerung, Verantwortung und Zukunft") and the German Federal Foreign Office. The Third Annual International Conference will take place in Sarajevo to contribute to Humanity in Action's expanding presence in Bosnia and Herzegovina.

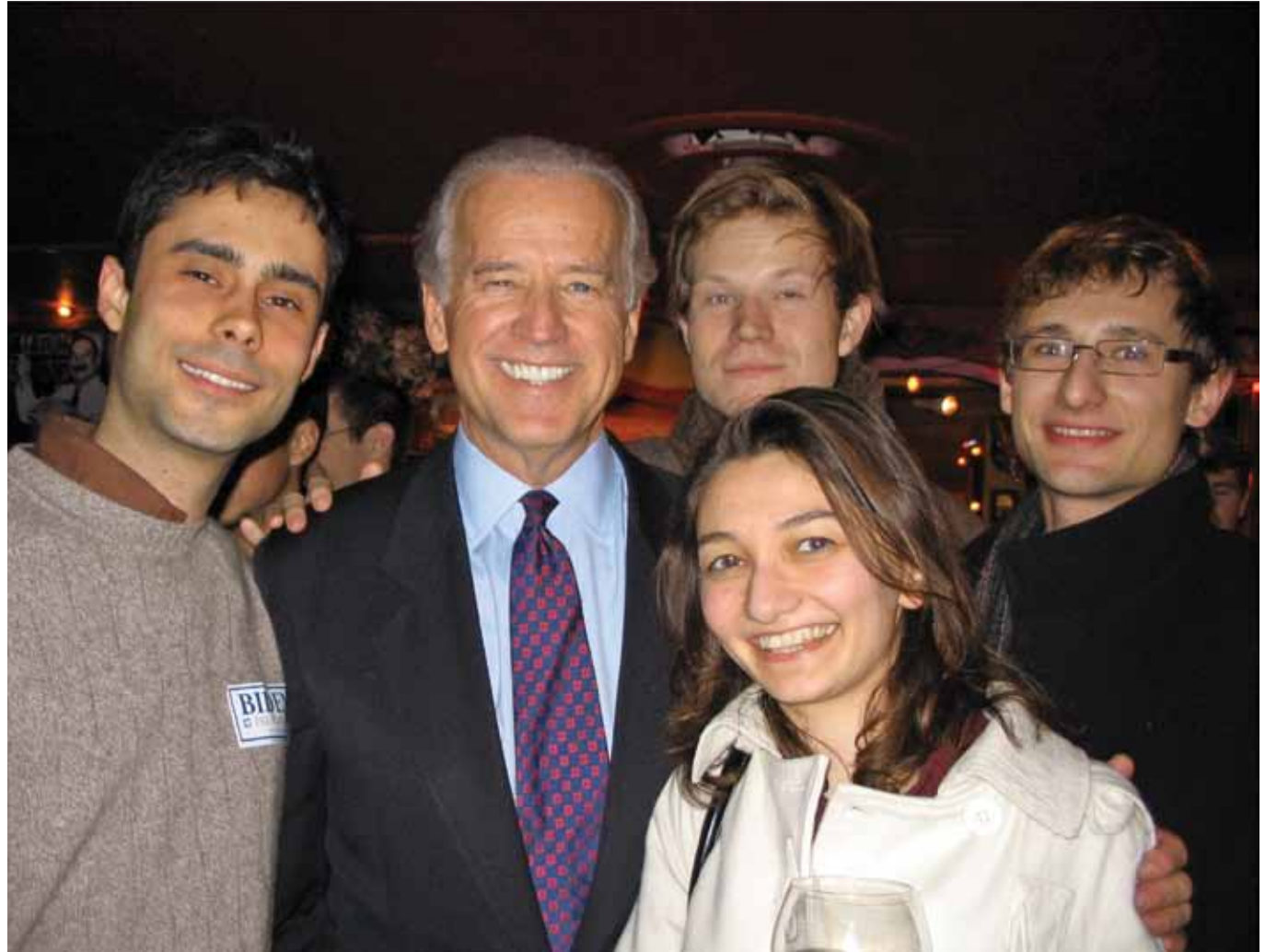

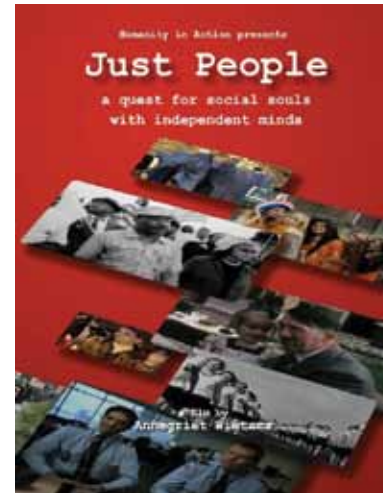
